Official Rules

1. **HOW TO ENTER:** NO PURCHASE NECESSARY. This giveaway starts March 26, 2017 and ends on March 30, 2017 at 10:29 a.m. CST. Entries may be submitted as described below.

Participation in this giveaway constitutes your full and unconditional agreement to and acceptance of these Official Rules and the decisions of NACE International (the "Sponsor"), which are final in all respects. To enter, fill out and deposit a the Harley Card you received inside of the *MP* Final Program along with the playing cards collected from visiting each "*High Rollin' for a Harley*" sponsored booth (and your full name and contact information) in the designated entry box at Corrosion 2017 (the "Conference"). Limit one entry per person. Multiple entries from one person will disqualify all entries. Sponsor and its agents are not responsible for incomplete, lost, late, damaged, illegible or misdirected entries, which will be deemed ineligible. Entries become Sponsor's property and will not be returned.

2. **ELIGIBILITY:** To participate in this giveaway, you must be an attendee of the Conference who is (i) 18 years of age or older at time of entry, and (ii) a licensed driver. Employees, officers and directors of the Sponsor and Harley Giveaway sponsors (including immediate family members and/or those living in the same household of each) are not eligible to participate.
